

Hawaii's Favorite Preschool Teacher & Favorite Family Child Care Provider - Official Contest Rules

How to Enter:

- Entries will be accepted until March 31, 2011.
- To enter, [fill out the online entry form](#).
- Entrants must fill out the online form in its entirety or entire entry will be disqualified.

Prizes:

Winners will each receive a prize package worth \$1,500. The prize package includes a \$1,000 certificate from Education Works to go directly to the benefit of the preschool at which the winning preschool teacher is employed, and a \$1,000 certificate from Education Works to go directly to the child care business of the winning family child care provider. The remainder of the prizes will go directly to the winners. Prizes will be awarded at a dinner celebration held at 3660 on the Rise, Honolulu on May 7, 2011. Actual winners from a neighbor island will be flown to Honolulu at PATCH's expense to receive the prize. Prizes are non-transferrable. No cash or other substitutions. Any and all federal, state and local taxes, fees and surcharges on prizes are the sole responsibility of the winners and their respective preschool and child care business.

Eligibility Restrictions:

- No Purchase is necessary.
- Void where restricted or prohibited by law.
- Open only to legitimate and lawful, licensed child care businesses located and registered to do business and operate in the state of Hawaii.

- Contest questionnaire must be filled out in its entirety online by an individual at least eighteen (18) years of age.

Finalists further agree to submit to an online polling of their application and that the winners will be solely determined by the highest number of online votes per the application.
